Online Courses Designed and Facilitated

Women's Body Peace Forum

This eight-week online intensive helps women untangle limiting beliefs and emotions about their bodies, and form Body Peace - a lasting relationship of love and respect between body and self. Students are given writing, reading, film, and creative assignments. An online message board is used to share and discuss assignments.

Follow the Dream

This eight-week online course guides participants through study in depth-oriented dream work, and facilitates a productive, reciprocal relationship with dreaming. Participants communicate on an online message board and work with reading, journal and creative assignments individually.
